## A Word From the Publisher

**M**anagers of corporate fleets are keeping one eye on Congress and federal regulators and another on the commercial freight market and a dwindling supply of qualified truck drivers as they try to provide additional hauling capacity and keep a lid on the rising cost of transportation.

It's a complex equation that is forcing shippers to focus more intently on getting more utilization from their existing truck fleets and doing all they can to protect and increase the productivity of their drivers.

"We need to increase our fleet by 8% to 10% to handle additional demand," said Victor Hart, manager of transportation safety for DOT Transportation in Mount Sterling, Ill.

A key to providing additional capacity, however, will be the ability of both private and for-hire carriers to find qualified drivers, based on interviews with fleet managers and industry experts by Senior Features Writer Daniel P. Bearth for the 2011 TRANSPORT TOPICS' Top 100 Private Carriers list.

While driver turnover among shipper-owned fleets is much lower than it is for for-hire carriers, a smaller pool of driver applicants and possible changes in the maximum time drivers can work will require new hiring strategies and operational changes.

"We are ramping up our recruiting efforts and reviewing our pay and benefit structure to be proactive and stay ahead of the issue," said Richard Evans, director of transportation for Valley Proteins Inc. in Winchester, Va.

Stan Brooks, senior director of transportation for carpet manufacturer Mohawk Industries in Dalton, Ga., said he is looking to use rail and ocean carriers for longhaul shipments and "co-loading," or combining freight with shipments from other companies to use empty space on trailers and offset some of the cost of transportation.

A major worry for nearly all private fleet managers is the possibility that the Federal Motor Carrier Safety Administration could cut the time drivers are allowed to spend on the road from 11 hours to 10 hours a day.

Such a change would wreck delivery schedules and

drive up operating costs.

"We would be forced to add additional equipment and drivers to the fleet, which in turn would add more congestion onto roadways," said Paul Clark, outbound transportation director for Truserv Logistics Co., a unit of hardware retailer True Value Co. in Harvard, Ill.

Food delivery fleets would be particularly hard hit by the new rules because it would limit the number of stops drivers could make during off-peak hours, said Michael Ahart, vice president of transportation for Dean Foods Co. in Dallas.

M.W. "Moe" Schroter, president of JBS Carriers in Greeley, Colo., who hauls frozen beef for JBS USA Holdings, said he would have to move to a more regional operation with more drop and hook applications.

"This will certainly cause more expense with equipment and drivers," he said.

One solution that could boost freight-hauling capacity and offset the loss of productivity is an increase in the federal weight limit for tractor-trailer combinations.

A bill that would allow states to raise the weight limit to 97,000 pounds with an extra axle from the current limit of 80,000 pounds has been introduced in the House and Senate, and some private fleet executives are hopeful that the proposal will be part of highway funding bill that is expected to pass later this year.

Whatever happens, it's clear that private fleet executives have a lot to think about.

And just as we expect drivers to be alert to changing road conditions, it's not unreasonable to expect that the companies on the Top 100 Private Carriers list will be among those that adapt most successfully to a constantly changing business and regulatory environment.
